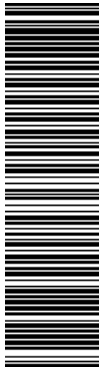

The Democratic Republic of the Congo embassy must receive approval from Kinshasa prior to visa issuance which can extend the processing time beyond 10 days.

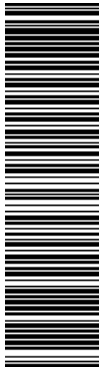


Democratic Republic of the Congo tourist visa checklist

- Filled out and signed Democratic Republic of the Congo tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- 2 Photographs.** Standard passport photographs 2x2 inches on a white background.
- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.com**.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.
- Itinerary.** Copy of an itinerary or flight reservation from an airline or travel agent. **Please do not purchase tickets until the visa has been issued.**
- Yellow Fever Vaccination.** A copy of the International Certificate of Vaccination (ICV) for yellow fever. To learn more about the yellow fever vaccination or to locate a vaccination clinic, please visit the CDC's yellow fever resource page.

Letter of Invitation. A letter of invitation from a tourist agency or private host in the Democratic Republic of the Congo. This letter must be notarized at City Hall in the DRC and legalized by the DRC Ministry of Foreign Affairs.

If the tourist is not using either a tourist agency or private host, then, they need to provide a letter stating the purpose of the trip, the site the tourist plans to visit and the duration of the trip. This letter should be notarized by local authorities in the U.S.

Declaration of Liability. A formal declaration of liability "engagement de prise en charge" issued by the Direction Générale des Migrations (DGM). A Sample of this letter can be found here.

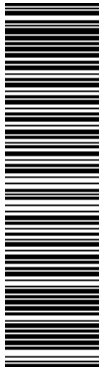

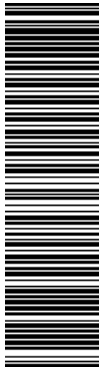

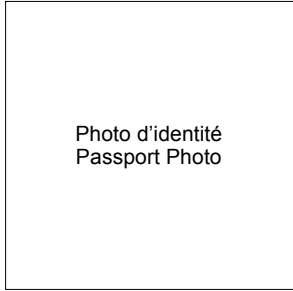
